- Individual Entry Fee \$40.00 AUD (Team Event Fees are \$90.00 AUD)
- Use only one entry form per person. Entry form must be validated by Chief Instructor.
- Age is determined by the age a competitor will be on 7<sup>th</sup> November 2008.
- If under 18 years of age, entry forms must be signed by BOTH parents/guardians.
- World Karate Federation rules will be applied to this tournament, subject to modifications by KBI.
- **The following safety equipment is COMPULSORY: WKF approved Gloves (Red and Blue). Shin & foot protectors. Mouth Guards. Groin Guards (males). OPTIONAL: Chest Protection for females.**
- Competitors wearing braces on teeth will require their mouth guard to be fitted by an Orthodontist.
- Senior Kumite maximum age is 45 years. Veterans Kumite 35 Years & Above – Note: Competitors 46 years and above must supply a medical clearance with their entry form.
- Kumite match times: Senior Male – 3 minutes; Children, Cadets, Juniors, Females, Veterans – 2 minutes
